



CLUB CONSTITUTION

1. NAME

This club will be called Mariners Baseball Ireland and will be affiliated to Baseball Ireland.

2. AIMS AND OBJECTIVES

The aims and objectives of the club will be:

- To offer coaching and competitive opportunities in Baseball
- To promote the sport of Baseball in the local community from youth to adult level
- To ensure a duty of care to all members of the club
- To provide all its services in a way that is fair to everyone
- To ensure that all present and future members receive fair and equal treatment

3. MEMBERSHIP

Membership should consist of officers and members of the club.

All members will be subject to the rules and regulations of the club and on joining the club they will adhere to all policies and procedures listed in the clubs constitution. Each member will also agree to adhere to the rules and regulations of Baseball Ireland.

Membership categories are as follows:

- Adult member
- Youth member

4. MEMBERSHIP FEES

Membership fees will be set annually and determined at the Annual General Meeting. Fees will be paid by annual subscription.

5. OFFICERS OF THE CLUB

The officers of the club will be

- President
- Vice President
- Secretary
- Treasurer
- Public Relations Officer
- Club Coach adult A team
- Club Coach adult B team
- Club Coach youth team
- Club Designated Liaison person (DLP)
- Club Children's Officer (CCO)

Officers will be elected annually at the Annual General Meeting. Committee members may not serve in the same position for more than three years without re-election. (subject to approval by the board members).



6. COMMITTEE

The club will be managed through the Management Committee consisting of the officers listed above. Only these posts will have the right to vote at meetings of the Management Committee.

The Management Committee will be convened by the Secretary of the club and held no less than 3 per year.

The quorum required for business to be agreed at Management committee meetings will be: 3

The Management Committee will be responsible for adopting new policy, codes of conduct and rules that affect the organisation of the club.

The Management Committee will have powers to appoint sub-committees as necessary and appoint advisers to the Management Committee as necessary to fulfil its business.

The Management Committee will be responsible for disciplinary hearings of members who infringe the club rules/regulations/constitution. The Management Committee will be responsible for taking any action of suspension or discipline following such hearings.

7. FINANCE

The Club Treasurer will be responsible for the finances of the club.

The financial year of the club will end on: 31st Dec.

A statement of annual accounts will be presented by the Treasurer at the Annual General Meeting. Also a further report may be provided during monthly or quarterly meetings

8. ANNUAL GENERAL MEETINGS

Notice of the Annual General Meeting (AGM) will be given by the Club Secretary. Not less than 21 clear days' notice to be given to all members.

The AGM will receive a report from officers of the Management Committee and a statement of the accounts.

Nominations for officers of the Management Committee will be sent to the Secretary prior to the AGM.

Elections of officers are to take place at the AGM.

All members have the right to vote at the AGM.

The quorum for AGMs will be 8

The Management Committee has the right to call Extraordinary General Meetings (EGMs) outside the AGM. Procedures for EGMs will be the same as for the AGM.

9. DISCIPLINE AND APPEALS

All complaints regarding the behaviour of members should be submitted in writing to the Secretary.

The Management Committee will meet to hear complaints within 7 days of a complaint being lodged. The committee has the power to take appropriate disciplinary action including the termination of membership.

The outcome of a disciplinary hearing should be notified in writing to the person who lodged the complaint and the member against whom the complaint was made within 7 days of the hearing.

There will be the right of appeal to the Management Committee following disciplinary action being announced. The committee should consider the appeal within 7 days of the Secretary receiving the appeal.



10. DISSOLUTION

A resolution to dissolve the club can only be passed at an AGM or EGM through a majority vote of the membership.

In the event of dissolution, any assets of the club that remain will become the property of Baseball Ireland

11. AMENDMENTS TO THE CONSTITUTION

The constitution will only be changed through agreement by majority vote at an AGM or EGM.

DECLARATION

Mariners Baseball Ireland hereby adopts and accepts this constitution as a current operating guide regulating the actions of members.
